The Men's Center, Incorporated, dba recenter, is a recovery program which follows the 12-Step model of Alcoholics Anonymous and provides housing for predominately homeless individuals, as well as non-medical alcohol detox and drug rehabilitation. During 2016, we served 599 individuals in our residential program. Since our beginning, we have served over 27,200 addicted individuals in our residential program; 225,000 through our 12 Step meetings and sponsor relationships; and have been attributed with positively impacting more than 544,000 lives in the Houston area. Our non-residential programs include 40 open meetings per week, a network of sponsors, an emergency shelter in times of natural disaster, meals for the homeless, referrals to area housing and many other supportive services.
